 (vi) Preparing statistical data

- It is possible for you to deny the provision of personal information to us in accordance with your wishes. In such cases, we may be unable to provide you with part or all of services that you have requested.

2. Provision of personal information to third parties

In order to implement the purposes of use stated above, our company shall provide information such as your name, gender, age, date of birth, permanent domicile, current address, telephone number, e-mail address, passport information, and credit card number to transportation & accommodation agencies, credit card
